**CORRIGENDUM DATED 09.11.2021.**

Final Common Seniority List of Inspectors (Preventive Officer) of Mumbai and Goa Customs upto the year 2014-15 was issued vide Circular No. 22/2017 dated 17.05.2017 strictly in accordance with the judgement of Hon'ble Supreme Court dated 27.11.2012 in case of UOI Vs. N.R.Parmar and Ors in Civil Appeal No. 7514-7515 of 2005 and DoPT O.M. No. 35014/2/80-Estt. (D) dated 07.02.1986 & DoPT O.M. No. 22011/7/86-Estt. (D) dated 03.07.1986 read with DoPT O.M. No. 20011/1/2012-Estt(D) dated 04.03.2014.

Consequent to Review DPCs for promotion to the grade of Inspector (Preventive Officers) for the vacancy year 2010-2011 and 2011-12 held on 27.11.2012 and 30.09.2021 respectively, the seniority position of some of the Officers was altered.
