**AUCTION NOTICE FOR DISPOSAL OF OBSOLETE E-waste ITEMS**

Sealed tenders are invited from the registered Recycler / Re-processor of E-waste with Central Pollution Control Board / State Pollution Control Board for auction of obsolete Cabinets, Printers, Monitor (CRT), Keyboard, Motherboard, Tinet, Typewriters, Mouse etc. on **“As is where is basis”** and as per CPCB ([www.cpcb.nic.in](http://www.cpcb.nic.in)) / SPCB / PCC guidelines for disposing off Recycling / re-processing of electronics waste. The reserve price of the goods for auction is fixed at Rs. 34,000/- as per valuation(s) of government approved valuer.

Total numbers of equipment / items are as per list attached in Annexure B (Lot I and II). It includes obsolete Cabinets, Printers, Monitor (CRT), Keyboard, Motherboard, Tinet, Typewriters, and Mouse etc. All the items as per Annexure - B, are located at New Custom House, Ballard Estate, Mumbai – 400 001. ## **Eligibility Criteria**

1. Valid Registration for Recycler/Re-processor of E-waste with Central Pollution Control Board/ State Pollution Control Board in terms of Ministry of Environment of Forest notification number S.O. 1035(E) Dated 12th May 2011.  
**A copy of the certificate must be attached with the bid.**
2. Copy of PAN CARD

## **General Terms & Conditions.**

1. The bids will be valid for a period of 30 days from the date of the opening of the bids.
2. The bidders may inspect the items on a pre- determined date and satisfy themselves about the items they are bidding for.
3. The items would be sold to the highest bidder;
4. GST will be extra, as applicable. Hence, the bidders are advised to submit the bids calculating the GST as applicable.
5. The Earnest Money Deposit (EMD) of the successful bidder shall be adjusted in the bid out forth. The EMD of the unsuccessful bidders shall be returned within 90 days of the auction date, without any interest.
6. No items, once disposed to the successful bidder, shall be taken back on any conditions whatsoever.
7. The successful bidder has to make full balance payment in the form of Demand Draft in favour of **“RBI A/C COMMISSIONER OF CUSTOMS (GENERAL), MUMBAI”** within 5 days after confirmation, failing which the offer will be cancelled and EMD shall stand forfeited.
8. The successful bidder shall be required to lift all the items from the disposal site to his premises within 5 days after the payment of balance amount. On failure to do so Commissioner of Customs (General) shall have the right to forfeit the entire amount of the bidder.

## **Terms & Conditions for Tender Quoted**

1. Quotation letter in a sealed envelope should be addressed to **“The Assistant Commissioner of Customs, CHS** on or before 02:00 PM 07.09.2018. The quotation must be submitted on or before the due date and time otherwise it will be rejected. Bids received after due date and stipulated date and time due to any reason whatsoever, including postal delays shall not be considered.
2. The financial bid be quoted both the figures and words along with GST, any. Any overwriting or erasing the figures shall not be considered for acceptance of the rates offered by the bidder. GST, if any, shall be borne by the bidder.
3. Commissioner of Customs (General) reserves the right to accept or reject any/ all bids without assigning any reason whatsoever.

4. Each page of the bid documents should be signed by the bidder(s). Incomplete and unsigned bids are liable to be rejected.
5. An Earnest Money Deposit (EMD) of **Rs.10, 000/-** (RS. TEN THOUSANDS ONLY) must accompany each bid. This shall be in the form of an account payee Demand Draft/Pay Order of any nationalized bank/commercial bank drawn in the name “RBI A/C COMMISSIONER OF CUSTOMS (GENERAL), MUMBAI” without which the bid shall be summarily rejected.
6. No cheque / money order/cash shall be accepted. The EMD deposit shall not attract any interest.
7. For financial evaluation, the highest bidder shall be chosen based on the figures quoted in Annexure-A.
8. An authorization/registration letter issued by concerned State Pollution Control Board for Recycler/Re-processor of E-waste is must to submit with bid as supportive document.
9. A Copy of the latest annual returns filed to the State Pollution Control Board for to Pollution Control Committee concerned as the case, must be submitted along with the bid as supportive document.
