Sub: Posting of Appraisers on loan basis from Customs formations to Directorates-reg

Please refer to CBIC Circular F.No A-11013/32/2021-Ad.IV dated 21.01.2022 regarding posting of Officers on loan basis from Customs formations to Directorates.

The above instruction permits Zones to post officers on loan basis to Directorates outside their jurisdiction. Board's Circular dated 27.5.2020 has now been extended to the 3 CCA of Customs formations. The guidelines formulated in the Board's Circular has now been made applicable to the officers(Preventive) Officers/Supdt Customs(P)/Examiners/Appraisers of Customs formation for posting on loan basis to DGRI,,DIC and DGARM(NCTC, Mumbai).

The work load of NCTC has increased manifold following its upgradation w.e.f 1.1.2021, the launch of export RMS, roll out of Container Selection Module in additional locations, New IPR module, E sealing Module in exports, ECCS, Risk Analysis and Data Analytics for incisive data analysis for proper risk evaluation and mitigation. This work requires extensive data analysis and meticulous monitoring on a daily basis. Considering the volume of work, a sizeable number of skilled officers, having Customs and IT knowledge, are required to be posted in NCTC. In the environment of faceless assessment the work of NCTC Cargo has substantially increased.

The officers posted in NCTC are coming from GST background and have no Customs experience. It is therefore requested to post Appraisers having appropriate education qualification (viz BTech, MCA) to this office. It may be appreciated that NCTC's work requires deeper understanding and knowledge of Customs laws and procedures including assessment and examination of goods as well as IT analytical skills and competencies.

It is therefore requested to post two Appraisers on loan basis to NCTC (DGARM), Mumbai for a period of 3 years.
