

AS APPLICABLE	<ol style="list-style-type: none">1. The goods are offered for sale on 'as is where is basis' and 'what is there basis' at buyer's risk without any guarantee as regards to quantity, quality and other physical parameters including required NOC, if any.2. Bidders are advised to inspect the lot carefully before bidding and Customs is not responsible for any discrepancy noticed at the time of delivery.3. The department takes no responsibility regarding registration of the vehicle under Motor Vehicle Act. All those vehicles which can't be registered according to Motor Vehicle Act will have to be dismantled as scrap or used as recycled part.4. The declaration will have to be provided by the successful bidder that the vehicle will not be used on road and will be recycled or sold as scrap.5. Except Delivery Order, no other document will be provided by the Customs Department.6. As per para 8.7.7 of Disposal Manual, 2019, H-1 bidders will be required to pay the EMD/ SD within 3 days from the date of closing of e-auction (irrespective of the date of issue of Sale Intimation Letter).7. As per para 8.7.10 of Disposal Manual, 2019, H-1 bidders will be required to submit the balance Sale Value with applicable duties/ taxes within the stipulated time, viz., 5 days from the date of issue of Sale Order.8. If full payment is not received within the next 7 working days after expiry of the above said (3-days for payment of EMD & 5-days for payment of balance sale amount) period, such lots will be put up in next e-auction without prior intimation to the bidder and all other terms and conditions of the e-auction will be applicable accordingly.9. After expiry of the above said period, acceptance of the payment shall be subject to approval of the Customs.10. DDs should be made in favour of RBI A/C COMMISSIONER OF CUSTOMS, MUMBAI. DDs pasted with any kind of transparent tape shall not be accepted.

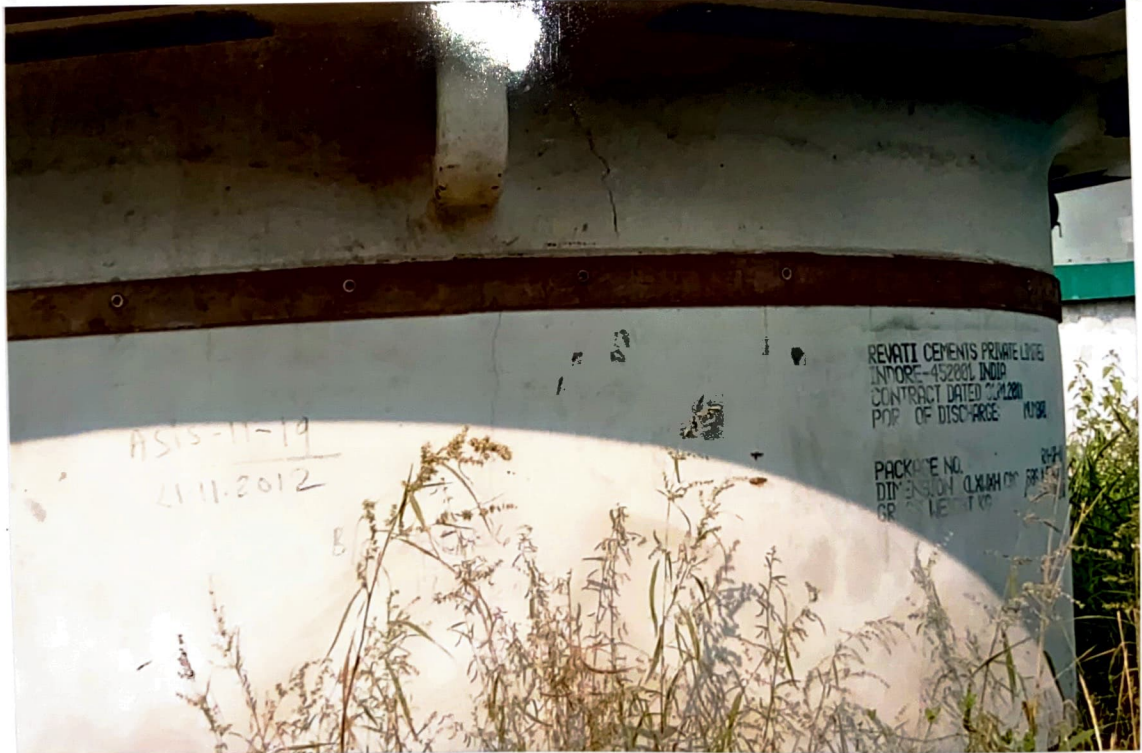
