CIRCULAR NO. 39/2018

It is proposed to fill up some regular posts in the grade of Appraisers in the pay matrix level 8 by way of conducting DPC subsequent to/ as a result of review exercise being undertaken in terms of order dated 31.10.2014 of Hon'ble CAT Mumbai in the matter of O.A. No. 38/2011 filed by Sumit Kumar & Ors. It is also proposed to fill up some temporary posts in the grade of Appraiser in the pay matrix level 8, promotions against which would be made exclusively on ad-hoc basis for a limited period of 360 days and no benefit of seniority on promotion would be admissible against those promotions. Therefore, willingness are called for from eligible Inspector (Preventive Officer), who have completed 03 years of regular service as on 01.04.2018.

2. It may be noted that the applications/willingness received in response to this particular circular will be considered only for the above said posts. All earlier willingness submitted to the department, will not be considered. The willingness submitted against this circular will be treated as willingness against regular as well as temporary post unless otherwise mentioned by the officers that they are not willing to be considered for promotion against temporary post. **Therefore, those officers who are not willing to be considered against temporary posts are to mention clearly in their application that they are willing to be considered against Regular posts only and not Temporary posts.**
3. The willingness for promotion to the grade of Appraisers should reach the undersigned on or before 10th October, 2018. Applications received after the aforesaid last date will not be entertained.
4. Candidates offering their willingness for the post of Appraiser is hereby informed that All India Seniority List in the grade of Appraisers is yet to be finalised by the Board. Due to introduction of quota of 20% in the Recruitment Rules of 1988 for Appraisers from feeder cadre of Preventive Officers, a few Promotee Appraisers promoted from the cadre of Preventive Officers likely to be pushed down and some of the officers down the line may have to be reverted, which may result in alteration of seniority and/or reversion.
5. All supervisory heads are requested to bring this Circular to the notice of all concerned.
6. This issues with the approval of the competent authority.
