**NOTIFICATION NO. 01 /2017.**

Vide Notification No.08/2015, offshore container terminal inside Mumbai port built by Mumbai Port Trust and M/s. Indira Container Terminal Pvt. Ltd was notified as a place for unloading of the imported cargo and loading of export vehicles as per the Custom Act, 1962 for a period of one year from 07.10.2015 to 06.10.2016 exclusively for RO-RO vessels and Mumbai port Trust was appointed Custodian under Section 45 of Custom Act 1962. As per proposal of Mumbai Port Trust vide letter No.TM/P-19-28/9931 dated 16.12.2015, Principal Commissioner of Customs (General) granted permission to Mumbai Port Trust to allow M/s. Indira Container Pvt. Ltd. (ICTPL) to handle for unloading all types of import cargo and loading of export of all types cargo up to 06.10.2016.

The above notification was further extended for 01 year up to 06.10.2017 vide Notification No. 09/2016

Now, in exercise of the powers conferred on me under Section 8 (a) of the Customs Act, 1962 I, Prachi Saroop, Commissioner of Customs (General), New Custom House, Ballard Estate, Mumbai hereby notify the completed area of Offshore Container Terminal (OCT) as described in the Schedule-I below, built by M/s. Mumbai Port Trust and M/s. Indira Container Terminal Pvt. Ltd. as a place for unloading of import of all types of cargo and loading of export of all types of cargo for a further period of one (01) year w.e.f. 07.10.2017 subject to the strict observance of the provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or Principal Commissioner of Customs (General), New Custom House, Ballard Estate Mumbai from time to time.

Further under section 10 of the Customs Act, 1962 I, Prachi Saroop, Commissioner of Customs (General) hereby specify the area described in Schedule-I below as the Boarding station for purpose of boarding of or disembarkation from vessels by officers of Customs.

Further, under Section 8 (b) of the Customs Act 1962, I, Prachi Saroop, Commissioner of Customs (General) hereby specify the limit of the Customs Area located inside Mumbai Port, Mumbai Port Trust, Mumbai, Maharashtra as under:
