CIRCULAR

The Development Commissioner, SEEPZ-SEZ, Andheri(East), Mumbai has intimated vacancy of (02) Superintendent of Customs and (05) Preventive Officers to be posted on deputation basis. In this respect, a panel of eligible Superintendents and Preventive Officers will be forwarded to the Development Commissioner, SEEPZ-SEZ for final selection. The eligible officers will be posted to SEEPZ-SEZ on deputation basis for a period of three years.

The Superintendents and Preventive Officers, who are fulfilling the following conditions (Please refer SEEPZ vacancy advertisement dated 08.10.2018 & Standing Order No.08/2017, dt 25.04.2017 issued by this office), may forward their willingness to this office in the prescribed format attached to this circular as Annexure-I:

Eligibility Conditions:

- (i) Clear from Vigilance angle.
- (ii) Not worked in SEZ in last 5 years.
- (iii) Not due for retirement till 30.11.2022.
- (iv) Minimum 5 years of experience in preventive cadre
- (v) Should have cleared departmental examination.

Apart of the above eligibility criteria, the following documents are also required:

- (i) APAR of the Superintendents and Preventive Officers for last 5 years duly attested by the competent authority.
- (ii) Vigilance Clearance Certificate
- (iii) The Integrity Certificate
- (iv) The details of penalty, if any, imposed during last 10 years or any proceedings pending.

The applicants may send their willingness 'through proper channel' to the undersigned in the prescribed format during working hours on or before **08.11.2018 by 05:00 PM** (also on email id "psoposting@gmail.com"). Applications received other than through proper channel or after the due date, will not be considered. On selection, no request of withdrawal of willingness will be accepted.
