ESTABLISHMENT OFFICE ORDER NO. 02 / 2022

A Review DPC for the promotions to the post of Inspector (Examiner) for the vacancy years 2014-15, 2015-16 & 2016-17 was held on 27.12.2021 which resulted in issuance of EOO No. 263/2021 dated 27.12.2021. As a result of the above said Review DPC, the inter-se seniority of the Examiners has been revised by the competent authority and published vide corrigendum dated 27.12.2021 to the Final Seniority List of Inspector (Examiner) vide Circular No. 58/2018 dated 29.01.2019 wherein some officers were given effect of promotion to the grade of Examiner for panel year 2016-17 instead of panel year 2014-15.

Consequently, a Review DPC of the supplementary DPC dated 11.06.2021 for the post of Appraiser was held from 28.12.2021 to 30.12.2021 for the vacancy year 2021 based on the relevant Recruitment Rules for the post of Appraiser. Based on the recommendation of the Review DPC, the following officers presently officiating as Appraiser are reverted back to the grade of Inspector (Examiner) in Level 7 in 7th CPC pay matrix (pre-revised Pay Band Rs. 9300-34800 with Grade Pay of Rs. 4600/- of 6th CPC) with immediate effect as they were not considered for the promotion to the grade of Appraiser for want of vacancy.
