4. The officers offered Regular as well as Ad-hoc promotion to the post of Appraiser for the first time shall assume charge not before 01.01.2022 and not later than 07.01.2022 (A/N) at their present Zone / place of posting failing which it will be construed that they are not interested in accepting the promotion. Failure to assume charge will be deemed as refusal to accept the promotion offered to them and action in terms of DOP&T OM No. 22011/5/86-Estt.(D) dt 10.04.1989 (as amended) read with DP&AR OM No. 22034/3./81-Estt(D) dated 01.10.1981 shall be initiated. The promotions would take effect only on assumption of charge at the concerned zone/place of posting. A copy of assumption of charge should be endorsed to the Deputy Commissioner of

Customs, Personnel & Establishment Section, New Custom House, Mumbai Zone-I and respective Appraising / Accounts Pay Bill Sections.

- 5. The pay and allowances of the newly promoted officers in the grade of Appraiser will be granted only from the date of assumption of charge. Promoted officers are entitled to exercise the option for fixation of pay on promotion in terms of FR-22(l)(a)(i) as per DoPT OM dated 27.07.2017 issued vide No.13/02/2017-Estt(Pay-I). They are hereby directed to exercise their option within one month from the date of this order.
- 6. The officers who names are featuring in the table at Para 3, are promoted on purely temporary/Ad-hoc basis for 360 days only. They are not eligible for any seniority on promotion or continuous officiation in the grade of Appraiser and can be reverted to their feeder grade without any further notice. The officers promoted on Ad-hoc basis vide this order shall stand reverted to their substantive posts in their respective feeder cadre on completion of 360 days i.e. on 26.12.2022 (F/N).
- 7. The subject promotions being effected under this order are subject to the final outcome of the following CAT / Court Cases:
- (a) Writ Petition No. 9921/2018 filed by Sanjay Mhatre & Ors before Hon'ble Bombay High Court challenging the order dt 31.10.2014 of Hon'ble CAT, Mumbai in O.A. No. 38 of 2011.
- (b) O.A. No. 571 of 2014 filed by Shri Pradip Kumar and Ors. before Hon'ble CAT, Mumbai bench.
- (c) O.A. No.650/2014 filed by All India Appraisers Association before Hon'ble CAT, Mumbai bench.
- (d) O.A. No. 831/2019 filed by Shri Rahul Ahlawat & Shri Rahul Beniwal before CAT, Mumbai Bench.
- (e) Any other case pending before any court of law having any impact on the seniority and promotions in the grade of Appraiser.
- (f) The promotions are subject to the further orders which may be passed by the Hon'ble Supreme Court as stipulated in DOPT's O.M. No. 36012/11/2016-Estt(Res-I) (Pt-II) dt 15.06.2018.
- (g) Any review measures taken by this Department regarding seniority and promotion in pursuance of any decision in any Court/ Tribunal cases.

- 8. The officers offered regular promotion to the post of Appraiser for the first time would continue to work on in-situ basis till the issuance of their posting orders.
- 9. The controlling officers to whom the officer is submitting assumption of charge shall also ensure that if any of the officer whose name mentioned in the list above, is under suspension or charge-sheet has been issued or prosecution has been launched, that officer should not be allowed to assume charge of the post of Appraiser and this fact should be reported to Joint Commissioner of Customs, P&E, New Custom House immediately.
