ESTT. OFFICE ORDER NO. 30 / 2022

A Departmental Promotion Committee meeting was held on 21.12.2021 for promotion from the grade of Executive Assistant to the grade of Administrative Officer (Group B, Gazetted, Ministerial) on regular basis for the vacancy year 2021 and 2022. On the basis of the recommendations of the said DPC, the following Executive Assistants are hereby promoted to the post of Administrative Officer in Level-7 in the Pay Matrix (Rs.44900-142400) on regular basis w.e.f. 01.02.2022.

2. The promoted officers are directed to assume charge not before 01.02.2022 and latest by 15.02.2022, failing which it will be construed that they are not interested in accepting the promotion. Failure to assume charge shall be treated as refusal to accept the promotion offered to the officer and action in terms of DOPT OM No. 22011/5/86-Estt.(D) dated 10.04.1989 shall be initiated.

3. The promotion shall take effect only after assumption of charge at the concerned Zone/place of posting. A copy of the assumption of charge should be endorsed to the Personnel & Estt. Section, New Custom House, Mumbai-I.

4. The pay and allowances of the newly promoted officers will be granted only from the date of assumption of charge. Promoted officers are entitled to exercise the option for fixation of pay on promotion in terms of F.R.-22(1)(a)(i) as per DOPT OM No. 13/02/2017-Estt.(Pay-I) dt 27.07.2017 within one month from the effective date of their promotion.

5. The above promotions shall be subject to the outcome of any relevant pending case in any Tribunal/ High Court / Supreme Court of India and/or

any review measure undertaken by this department in pursuance of any decision of any Tribunal/Court and/or any direction of the Ministry pursuant to any judicial order.

6. The controlling officer shall ensure that if any of the officers whose names figure in this order are under suspension or facing any charge-sheet or prosecution, he/she should not be allowed to assume charge of the post and this should be immediately reported to the P&E Section, NCH, Mumbai Zone-I. Further, if any officer is undergoing any penalty, he/she should be allowed to assume the charge of the post only after the expiry of the currency of the penalty period and this should be reported to P&E Section, NCH, Mumbai-I.
