**Sub: Stand Relieving Order in the grade of EA (STA+DOS), TA -reg.**

Consequent upon issuance of Centralized Order No. M-I/NCH/P&E/ EA(STA/DOS)/TA/01/2018 & Estt. Officer Order No. 410 /2018 & 411/2018 dated 11.01.2018 also Estt. Office Order No. 414/2018 dated 18.01.2018 within Zone-I, all the officers were required to be relieved by the stipulated dates in a phased manner.

In this regard, a letter addressed to the Addl. Commissioner of Customs, Zone II & Zone-III vide F.No. S/5-83/2017-18 Estt dt. 26.02.2018 & dated 16.03.2018 were also sent to relieve the above referred officer within stipulated date but not reply has been received till date.

In absence of any specific request received from the Controlling Officers/The Principal Commissioners (General)/Commissioners, all the officers, who have not been relieved so far, hereby stand relieved with immediate effect.

It is also directed to Accounts Pay bill of all three zones to ensure that the salary of the officers whose names mentioned in the said orders will be drawn from the concerned account pay bill of their new place of posting.

The Deputy / Assistant Commissioner of Customs, Office of Chief Commissioner of Customs, Zone II & III, the Deputy Commissioner of Customs Appraising (Main), Zone I and the Deputy Commissioner of Customs Export (Admn), Zone-I shall send a consolidated compliance report of Relieving and Joining of Officers to the Principal Commissioner of Customs (General), New Custom House, Mumbai in this regard latest by 25.05.2018.
