**TRADE FACILITATION CIRCULAR**

**Sub: Augmenting the number of AEOs in the country to 3000 – reg.**

Kind attention of Members of Trade (viz. Importers, Exporters, Logistic Operators, Warehouse Operators, Custom Brokers etc.) dealing with EXIM Cargo is invited to CBEC Circular No. 03/2018-Cus Dtd. 17.01.2018 on the subject "Amendment in the AEO Programme Circular No. 33/2016 dated 22/7/2016" (Copy of Circular No. 03/2018-Cus. enclosed).


2. Para 2(ii) of Circular No. 3/2018-Cus amends Para 2.4 of Circular No. 33/2016 dtd. 22/7/2016 and it reads as below :

"The application should be sent directly to the respective jurisdictional Customs Chief Commissioner's Office with a copy to the AEO Programme Manager, Directorate of International Customs or in case of any doubt, to the AEO Programme Manager, Directorate of International Customs, 10<sup>th</sup> Floor, Jeevan Bharti Building, Connaught Place, New Delhi-110 001".
