OFFICE ORDER

In pursuance of Break the Chain Order no. DMU/2020/CR.92/DISM-1 dated 12.05.2021 issued by Government of Maharashtra in response to Covid-19 pandemic, necessary roster of staff/officers with staggered timings is to be drawn to render essential function from 17.05.2021 till 31.05.20231 or further orders whichever is earlier. Accordingly, the Appraising Officers working under following Deputy / Assistant Commissioners in-charge of Assessing Groups of Import-I and II Commissionerates, Mumbai Customs will attend the duties as per timings shown against the names of their respective DCs/ACs from 17.05.2021 onwards as under:

However, in case of exigencies of work, the officers working in 1st shift may work beyond prescribed time and officers working in 2nd shift may attend their duty earlier than prescribed time.

The link officer arrangement issued under earlier orders dated 23.04.2021 and 30.04.2021 shall continue to be in operation till further orders.

Further, the DCs/ACs of Import-I and import-II should insure that the other staff working under them attends the office in terms of the guidelines issued by Government of Maharashtra vide Break the Chain Order no. DMU/2020/CR.92/DISM-1 dated 12.05.2021.
