3. The officers concerned may exercise the option for fixation of pay in terms of FR-22(l)(a)(i) as per DoPT OM dated 27.07.2017 issued vide No.13/02/2017-Estt(Pay-I) in the higher grade afresh within one month of issuance of this order. Such option once exercised shall be treated as final.

4. Any changes in the inter-se seniority of Appraisers/seniority position of Shri Pradeep Rana consequent upon issuance of this order shall be reflected in the seniority list separately.

5. The officer shall not be eligible for any arrear of salary and allowances consequent upon issuance of this order.

6. The subject promotion being effected under this order is subject to the final outcome of any case pending before any court of law having any impact on the seniority and promotions in the grade of Appraiser, Inspector (Examiner) and/or Inspector (Preventive Officer) or feeder cadre and any review measures taken by this Department regarding seniority and promotion in pursuance of any decision in any Court/ Tribunal cases.
