It has been directed by the Competent authority that the respective Controlling Officers shall ensure that all the officers are relieved by the above specified instructions and send a consolidated report of relieved and joined officers to the O/o the Deputy Commissioner of Customs, P&E, Mumbai Customs Zone-I by 05.03.2024.

5. The official who have been retained even after completion of his/her tenure as per their representation, shall be given non-sensitive charge.
