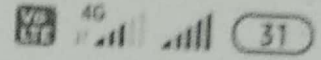

**Subject: Reservation in promotion in all IDENTIFIED POSTS
in Group A & B Posts of Mumbai Customs -reg.**

Most respectfully, I want to submit that the Honorable Supreme Court of India in the matter of **Rajeev Kumar Gupta & Ors Versus Union of India & Ors** on 30.06.2016 in Civil Appeal No. 5389 of 2016 had directed the Government to extend three percent reservation to PWD in all IDENTIFIED POSTS in Group A and Group B, irrespective of the mode of filling up of such posts.

Again the Honourable Supreme Court of India on 14/15.01.2020 in the matter of **Siddaraju Versus State of Karnataka & Ors** in Civil Appeal 1567 of 2017 had upheld the judgement given in the matter of **Rajeev Kumar Gupta & Ors Versus Union of India & Ors** on 30.06.2016.

Therefore, please direct the competent authority of Mumbai Customs to extend 3% reservation from 1995-96 to 2015-16 in promotion to the post of Executive Assistant, Examiner, Preventive Officer, Administrative Officer, Superintendent (P) and Appraising Officer and 4% reservation in above post from 2016 onwards.

It is also requested to consider this request letter as my representation for implementation of the Persons With Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 as well as Rights of Persons with Disabilities Act, 2016.
