- 3. At the outset, Commissioner of Customs (Import I & II) welcomed all the members of trade as well as the officers present for the meeting. He requested trade to take up points in this PTFC.
 - i. To begin with, Harsh Lapsia informed the forum that, there are no issues pending with Customs, Isolated issues of faceless assessment are being tackled by R.K.Singh, Addl. Commissioner regularly. The main issue is persistent connectivity problem at Docks. Commissioner (Import) informed that the optical fiber cable is being laid and problem is being tackled. Harsh informed that there is considerable improvement in nature of queries raised and the queries are also very less.
 - ii. With regard to payment of 2.5% BCD on denatured ethyl alcohol, Commissioner

informed that 2 to 3 importers have already paid differential duty and requested associations to pursue with other importers to make payment so that the issue can be closed. Moreover, direction is already given to finalise all the provisional assessment cases on this issue within one month.

iii. Naresh Nasta informed that 1st check examination orders are almost negligible and quality of queries have improved. Commissioner (Import) informed that if there are any issues related to queries,the same may be brought to his notice for immediate action.. Shri Naresh Nasta informed that base oil data will be submitted soon to customs for taking decision on test report. On the issue of inability of payment of IGST on line for old IGST /advance licence and drawal of multiple test sample from same tank for liquid bulk cargo, Commissioner asked to represent the issue in writing.

The meeting concluded with a vote of thanks to the chair.
