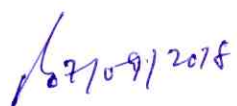
3. The pay and allowances of the newly promoted officers in the grade of Appraiser will be granted only from the date of assumption of charge. Newly promoted officers would not be entitled for any arrears on account of retrospective promotions.

4. The officers who were earlier promoted to the grade of Appraiser on regular basis and whose effective date of promotion has now been changed would not be entitled for any arrear for the non-officiating period.

5. The promotions are subject to the outcome/ final culmination of the following Court Cases and CAT Cases:

- (a) O.A. No. 571 of 2014 filed by Shri Pradip Kumar and Ors. before Hon'ble CAT, Mumbai bench.
- (b) W.P. No. 4855/2004 of Hon'ble Bombay high Court filed by All India Customs Appraising Officers Federation.
- (c) W.P. No. 2183/2018 filed by UOI vs. Sumit Kumar & Ors. in the Hon'ble Bombay high Court in the matter of O.A. No. 38 of 2011.
- (d) O.A. No. 348 of 2011 in Hon'ble Tribunal, Bombay Bench, Mumbai filed by Shri Sunil Kumar Lamba & Ors.
- (e) Any other case pending before any court of law having any impact on the seniority and promotions in the grade of Appraiser, Inspector (Examiner) and/or Inspector (Preventive Officer).
- (f) Any review measures taken by this Department regarding seniority and promotion in pursuance of any decision in any Court/ Tribunal cases.
- (g) Rest of the officers who are already promoted to the grade of Appraiser on regular basis and their names do not feature in this order are to continue officiating in the present grade of Appraiser, as the case may be, till the review exercise up to the year 2018-19 in the grade of Appraiser are completed and orders are issued.
