


3. All the respective Zones may issue their Intra Zonal Order latest by 15.06.2022.

5. It is responsibility of the concerned controlling authorities to ensure non sensitive charges/posting to the officers not clear from the vigilance angle.
6. The above mentioned officers shall report to Posting Section, Mumbai Zone-I, after relieving and before joining their new place of posting.
7. PSO/Administration sections of respective Zones, shall forward the compliance report regarding relieving and joining of officers latest by 08.07.2022.
