- 2. All the candidates are required to arrange for their own books for the ensuing examination. The application of all eligible candidates should reach the P&E Section latest by 14/07/2021 in the prescribed proforma (Annexure 'A'). Application received after this date will not be entertained under any circumstances.
- 3. Further, in terms of Rule 7 (1) (4) & (5) of the Departmental Examination Rules, 2008,
  - 3.1. An officer, who has passed his matriculation or an equivalent or higher examination with Hindi as one of the subject, may be exempted from taking the examination in Hindi by the Commissioner Concerned, provided that this concession shall not be admissible to an officer who offered Hindi as an optional subject and failed to pass in it at the matriculation or higher level examination.
  - 3.2. The officers who did not take the examination in Hindi as a part of their Matriculation or equivalent examination but who have passed first year Intermediate Arts Examination with Hindi as a compulsory subject may also be exempted from passing the departmental examination in Hindi.
- 4. Such candidates who wish to seek exemption from appearing in Paper-VI (HINDI) of the said departmental examination may forward duly attested photocopy of the marks Sheet along with their ANNEXURE 'A'.
- 5. All the head of sections / departments are requested to bring this circular to the notice of all the concerned officers who are on deputation with/to the Directorates/Departments/Organizations and including their requirements also to take the initiative so as the willingness of the candidates reaches well in time to enable this department to conduct the examination effectively.
- 6. Note:- Mobile phones or any other electronic device are not allowed during the examination. Any infringements of these instructions shall entail disciplinary action.
