CIRCULAR NO. 31 /2021

Vacancies in the grade of Inspector (Preventive Officer) Group 'B' Non-Gazetted, Non- Ministerial in Level 7 in the Pay Matrix (44900-142400) for the vacancy year 2022 are proposed to be filled up through Promotion from/amongst the officers of the feeder cadres.

2. These Vacancies will be filled up as per New Recruitment Rules for the post of Inspector (Preventive Officer) notified by Ministry vide G.S.R. 1172 (E) dated 26.12.2016. The eligibility criteria as on 01.01.2022 for the candidates to be considered for promotion to the grade of Inspector (PO), is as under:

1. The candidate of the following categories should pass the Departmental Qualifying Examination:

I. The Executive Assistant or Stenographer Grade – I in level – 6 in the pay matrix (Rs. 35,400/-,1,12,400/-) with five years' regular service in the grade.

II. The Executive Assistant or Stenographer Grade-I with fifteen years' combined regular service in level – 6 in the pay matrix (Rs. 35,400-1,12,400) and in level -4 in the pay matrix (Rs. 25,500-81,100).

III. Officials (Woman Searchers or Tax Assistant or Stenographer Grade-II) in level – 4 in the pay matrix (Rs. 25,500-81,100) with fifteen years regular service in the grade.

Note 1: The officials in the given level (s) in the pay matrix, who are confirmed or permanent officials of the Department as on the date of commencement of these rules and who were eligible to participate in the LDCE conducted prior to such commencement shall continue to be eligible to participate in all the LDCE on an equitable basis.

Note 2: The officials in the given level (s) in the pay matrix, in the stenography cadre, who join the Department after the date of commencement of new RRs shall not be eligible to participate in LDCE conducted after the date of such commencement.

Note 3: Candidates shall be required to pass such written tests as may be determined by the Central Board of Excise and Customs from time to time and the written test shall be qualifying in nature and the marks obtained in the tests shall not be counted towards determining seniority.

B. The Candidate should possess a Degree from a recognized University or Institute.

C. The Candidate shall be required to pass physical test and to possess physical standards as prescribed below:

For Male Candidates:

(i) Physical standards (Minimum)

Height: 157.5 cmx (relaxable by 5 cms. In the case of Garhwalis, Assamese, Gorkhas and member of Scheduled Tribes.)

Chest : 81 cms (fully expanded with minimum expansion of 5 cms)

Walking : 1600 meters in 15 minutes

Cycling : 8 kms in 30 minutes.

For Female Candidates:

(i) Physical standards (Minimum)

Height – 152 cms

Weight – 48 kgs

(Height relaxable by 2.5 cms. And weight relaxable by 2 kgs In the case of Garhwalis, Assamese, Gorkhas and member of Scheduled Tribes)

(ii) Physical Test :-

Walking : 1 km in 20 mins

Cycling : 3 kms in 25 mins.

3. The Willingness in the prescribed Proforma (attached herewith) should be submitted to the office of the undersigned with intimation to the respective heads of the Sections/Units/Groups. The heads of the Sections/Units/Groups are requested to bring this circular to the notice of the candidates working under them including those on leave. Application should reach the undersigned not later than **29.10.2021 by 05:00 PM positively**. Applications received thereafter will not be entertained. Promotion secured on the basis of false information furnished in the Application/Proforma is liable to be terminated forthwith, apart from any disciplinary action that might be taken against the individual including dismissal from the service. No medical certificate from any medical authority is acceptable in lieu of physical standard test. Officers working as Inspector (PO) on ad-hoc basis need not give fresh willingness.

4. The names of those who have given willingness will be displayed on the notice board at **03:00 PM on 03.11.2021**. Any officer who had exercised his/her willingness and whose name does not figure in the said list is required to contact the undersigned by **06:00 PM of 05.11.2021**, with an office copy of his willingness.

5. The candidates submitting their willingness have to undergo a physical/medical standard test. The date of physical / Medical standard test will be displayed in the Notice Board of the P&E Section, NCH, Mumbai and it is the duty of the willing officers to keep track of the date of such test.

6. Candidates offering their willingness for the post of Inspector (PO) are informed that the promotions to the post will be subject to the outcome of pending court cases and also to any revision or review measures undertaken by the department regarding seniority and promotion in pursuance of any decision in any Court /Tribunal and the candidate offering their willingness for the post of Inspector (Preventive Officers) will not be permitted to withdraw their willingness under any circumstances.

7. All Supervisory heads are requested to ensure bringing this circular to the notice of all concerned.
