Subject: Inclusion of PwBD candidates in the AISLs of all three feeder cadres for promotion to the grade of Assistant Commissioner against the vacancy year 2013-14 to 2023 regarding.

Kind attention is invited to the letter dated 29.12.2023 issued vide F. No. 8/B/20/HRD(HRM-I)/Misc/2023 by the DGHRD, New Delhi on the above mentioned subject. Vide the above letter, it is directed that an exercise may be undertaken by all the Cadre Controlling Zones to identify all PwBD candidates in the AISLs of three feeder Cadres i.e. Superintendents C.Ex., Superintendent of Customs (P) & Appraisers for the post of Assistant Commissioner till date.

In this connection, it is requested to all PwBD candidates across all three zones of Mumbai Customs and Goa Customs zone to check whether the PwBD category is correctly indicated against their names in the Final Common Seniority List of Mumbai & Goa Customs (enclosed herewith) for the periods: - 1) 01.07.2001 to 30.06.2015 issued vide Circular No. 17/2016 dated 20.05.2016 and 2) 2014-2017 issued vide Circular No. 36/2023 dated 25.04.2023 & to ascertain the same in the corresponding Final All India Seniority Lists (AISLs) of Superintendents of Customs (Prev.) published by DGHRD, New Delhi.

Further, it is requested that the Superintendents (Prev.) belonging to PwBD category whose category does not figure correctly against their name in the said seniority lists, may also intimate to this office for inclusion in the lists within 02 working days.
