- (2). Tax Assistants and Stenographers Grade II (erstwhile Steno-III) who have successfully completed the period of probation and cleared the confirmation exam in the grade.

The application should reach the P&E Section not later than 14.01.2022 in the prescribed proforma (Annexure 'A'). Candidates are requested to inform whether Hindi version of question papers is required or otherwise.
