

NO. *1(20,31); 2(4,22); 4(3); 34(1); 36(2); 44(1); 46(3); 61(4);* ARE NOT OR SHOULD NOT BE POSTED TO SENSITIVE CHARGES. ANY GR. 'C' OFFICERS WHO ARE UNDER SUSPENSION HIS/HER NAME NOT SHOWN IN THIS TRANSFER/POSTING ORDER.
6. THE OFFICERS MARKED AS (#), PLACED AT SR./SUB SR. NO. *4(22); 6(1,3); 12(1); 19(1); 21(1); 24(2); 38(7); 55(2); 56(2);* ARE ALSO NOT TO BE GIVEN ANY SENSITIVE CHARGE BY THE CONCERNED CONTROLLING AUTHORITIES, SINCE THEY HAVE NOT COMPLETED THREE YEARS OF SERVICE.
7. THE OFFICERS MARKED AS (@), PLACED AT SR./SUB SR. NO. *5(56, 25(14))* ARE ALSO NOT TO BE GIVEN ANY SENSITIVE CHARGE AS THEY WERE ON LEAVE MORE THAN 45 DAYS.

9. ALL ADMINISTRATIVE HEADS SHOULD NOTE THAT IF ANY HEAD HAWALDAR/ HAWALDAR PROCEEDS ON LEAVE / OR REMAINS ABSENT, THE SUBSTITUTION SHOULD BE PROVIDED BY DIVERTING OTHER H/HAWALDAR / HAWALDAR WORKING UNDER THEM.
