### **CIRCULAR**

Sub:- Revision in seniority positions of Inspectors (Preventive Officers) appointed later vide additional results of CGLE-2012- Implementation of Hon'ble CAT Order dated 07.02.2023 in OA No.341/2022 filed by Shri Shahid Idrisha & Ors.- reg.

The final seniority list of Inspectors (Preventive Officers) of Mumbai and Goa Customs w.e.f recruitment year 2013-14 to recruitment year 2017-18 was issued vide Circular 44/2021 wherein the seniority of the following Inspectors whose names figure in Annexure B of the said Circular was referred to the Board for further directions.

- 1. These officers shown here-under recruited against additional result of SSC CGLE-2012 were appointed in 2018 & 2019 in this zone and they were promoted to the post of Superintendent of Customs (P) in the vacancy year 2023 vide EOO No 294/2022 dated 30.12.2022, EOO No 252/2023 dated 16.08.2023 & EOO No 281/2023 dated 06.09.2023.
- 2. Board vide letter F.No.A.32022/110/2019-Ad.IIIA dated 10.1.2024 conveyed its acceptance of the Hon'ble CAT, New Delhi order dated 7.2.2023 in OA No.341/2022 filed by Shri Shahid Idrisha & Ors. In the said letter, Board has directed all the CCAs to extend the benefit of the decision to the similar candidates appointed on the basis of additional result of the SSC CGLE-2012 [but joined later on different dates] by giving notional seniority as per their rank order in CGLE-2012 and consequential benefits as per applicable provisions.
- 3. Accordingly, in pursuance of aforementioned Board's letter dated 10.1.2024 and in supersession to the seniority list published vide circular no 22/2017 dated 17.05.2017 for Inspectors (Preventive officers) of Mumbai and Goa Customs up to the year 2014-15 earlier in this zone, the seniority of the said candidates appointed later vide additional results of CGLE-2012 stands revised as per their rank order in SSC CGLE-2012 as shown in the table below.
