PSO/NCH/PO./06/2022, Preventive Service Order No. 07/2022 dated 26.05.2022 in the grade Superintendent of Customs (P) and Inspector (Preventive officer) respectively issued vide F. No. S/43-343/21-22 P (PSO) and subsequent issuance of Intra Zonal Order vide Centralised order No. M-I/GEN. COMMR.
