
CIRCULAR NO.15 /2022

Reference is invited to the Circular No. 13/2022 dated 07.04.2022 wherein representations regarding AGT-2022 of Appraisers and Inspectors (Examiners) were called for. In this regard, kind attention is invited to the Standing Order No. 05/2022 dated 06.05.2022 wherein the following amendments in the Para 3.ii and Para 4.1 of the Standing Order No. 09/2017 dated 25.04.2017 are made: -

- i. The tenure of postings for Appraisers and Examiners in Mumbai Customs Zone-I will be for 03 years.
- ii. Outstation posting of Appraisers under Mumbai Customs Cadre Control will be for a period of three years which can be reduced on representation of the officer by the Pr. Chief Commissioner of Customs, Zone-I. This amendment will come in force prospectively.

In view of the above amendments in the Inter Zonal HR Policy of the Appraisers and Inspectors (Examiners), fresh representation regarding posting in Zone-I and Outstation posting, if any, from Appraisers and Inspectors(Examiners) are being invited **latest by 06.30 PM on 11.05.2022 (Wednesday)**. A duly signed copy of representation, if any, may be submitted to the Deputy Commissioner of Customs, P&E Section, Mumbai Customs Zone-I directly through e-mail to p.estt-mum-cus-zone1@gov.in.

Officers who have already submitted their representations against Circular No. 13/2022 dated 07.04.2022 need not submit the same representation again. The request/representation/preference submitted after the due date i.e. 11.05.2022 shall not be considered.
