Please refer to your letter F. No.S/43-651/06-07-P(M) dated 19.02.2008 on the above subject.

2. A Memorandum was issued by this Section on 03.06.2008 to Shri R. B. Chavan, Sepoy No.281 directing him to resume his duties and submit his explanation for his unauthorized absence. Shri R. B. Chavan has resumed his duties on 27.06.2008 and has submitted Medical Certificates for his absence from 19.10.2006 to 13.07.2007 and 19.10.2007 to 26.06.2008.
3. Disciplinary action was initiated against Shri R. B. Chavan for his unauthorized absence on earlier three occasions for which, the Joint Commissioner of Customs (P&V) had, vide Order-in-Original No.S/9-34/2003 Vi/1927 dated 10.12.2003 imposed penalty of reduction of pay by three stages for 3 years w.e.f 01.01.2004, with further directions that he would earn increments during the period of reduction and on expiry, the reduction will not have the effect of postponing his further increments of pay. It was also ordered that his period of absence be regularized as per leave rules. However, the said order has still not been implemented.
4. In his resumption report /explanation dated 16.07.2007, he had submitted that after resuming duties on 13.03.2006, he had been coming regularly to Office till 18.10.2006 for about more than 7 months, still the Order of the Disciplinary Authority vide Order-in-Original No. S/9-34/2003 Vi/1927 dated 10.12.2003 was not implemented and even his salary for the period for which he was attending his duties was not drawn. Since the Officer has now resumed his duties and has also submitted his explanation along with medical certificates covering his absence for the period from 19.10.2006 to 13.07.2007 & 19.10.2007 to 26.06.2008, you are directed to implement the order of the Disciplinary Authority passed earlier and to regularize his entire absence including the period of absence from 19.10.2006 to 13.07.2007 and 19.10.2007 to 26.06.2008.as per Leave Rules. His salary may also be drawn as per rules.

Chavan, Sepoy No. 281 under Rule 16 of CCS (CCA) Rules 1965 reduction of three stages in time scale of pay of Rs. 2610-60-3150-65-3540 of three years with effect from 01.01.2004 with further direction that Shri R. B. Chavan will earn increment of Pay during of pay during the period of reduction and that on expiry of this period the deduction will not have the effect of postponing his further increment of pay. 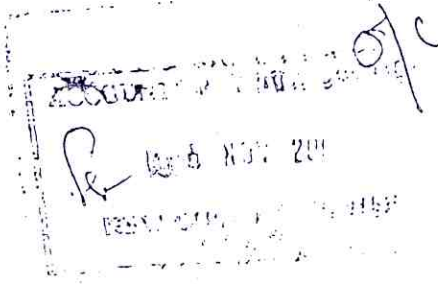





Please refer to your RTI application dated 29.10.2018 received in this office on 29.10.2018. The information has been received from the Accounts Pay Bill Section and the reply is given below:

"The officer was on leave from Jan-2003 to April-2011. However, as per available records the bill will be processed.

The officer has availed the leave from 29.09.2016 to 04.12.2016 (HPL), 05.12.2016 to 23.12.2016 (EOL), 06.02.2017 to 15.02.2017 (HPL), 16.02.2017 to 07.04.2017 (EOL), 15.05.2017 to 24.05.2017 (HPL) and 25.05.2017 to 01.09.2017 (EOL). The total recovery of the said period was Rs. 2,34,572/-. The recovery of Rs. 1,09,572/- has been recovered and the balance amount of Rs. 1,25,000/- is still pending.

Vide letter No. GRC/05/2018(P) dated 28.02.2018 received from AC/P(G), NCH intimated that the officer was absent from his duty from 24.10.2017 without intimation to this office and requested to stop his salary."
