In this instruction, the DoPT has issued OM No. 36012/11/201 6- Estt. CCUM1/R/2018/80072 dated 05.11.2018, registration No. CCUM1/R/2018/80073 dated 05.11.2018 both transferred to this office from Chief Commissioner of Customs, Mumbai Zone II and Registration No. CCUM3/R/2018/80056 dated 02.11.2018 received in this office on 06.11.2018 from Chief Commissioner's Office, Mumbai Zone I.

In this regard, attention is drawn to Circular No. 03/03/2017 dated 10.03.2017 wherein it is mentioned that :

The Central Information Commission, vide its decision No. CIC/AD/A/2013/001326-SA dated 25.06.2014 has thus, decided that :

- (i) No scope of repeating under RTI Act.
- (ii) Citizen has no Right to Repeat.
- (iii) Repetition shall be ground of refusal.
- (iv) Appeals can be rejected."

It is seen that vide your earlier RTI applications dated 04.09.2018 and 07.09.2018 you have sought the same information. The reply to the said RTI application

has already been sent vide this office letter bearing F. No RTICG/Gen-175/2018-19 dated 03.10.2018.

In view of the above, the information sought by you is denied being repetitive in nature.
