Please refer to your RTI application no. CCUM1/R/E/20/00138 dated 08.12.2020 received in this office on 08.12.2020. The requisite information was sought from the concerned sections. After due examination of the reply received from the concerned sections, the reply is as follows:

In this regard, it is informed that the counterfeit goods imported by importer M/s. Genius Trading vide B/E No.8358943 dated 19.12.2015 were absolutely confiscated under Section 111 (d) of the Customs Act, 1962. The competent authority, vide the Order-in-Original F. No. S/26-Misc-448/2015 Gr.VB /S/10-Adj6(ADC-2)/2015 VB dated 26.10.2015 has also ordered to dispose of the infringing goods in terms of the Rule 11 of the IPR Rules, 2007.

However, the goods are still pending for destruction by Disposal Section and the submitted BG can only be released on receipt of destruction memo from Disposal Section.

Further, it may be mentioned that BG of SBI bearing No. 0444916BG0230848 for Rs. 11,124/- has been duly extended upto 17.04.2021.
