प्रस्तावना

2. इस निर्णय के विरुद्ध, प्रथम अपीलीय प्राधिकारी, अपर आयुक्त सीमाशुल्क (आयात), प्रथम तल, नवीन सीमाशुल्क भवन, बेलार्ड इस्टेट, मुंबई- 400 001 के समक्ष अपील की जा सकती है।
3. सूचना का अधिकार अधिनियम, 2005, की धारा 19 के अनुसार इस निर्णय की प्राप्ति के 30 दिनों के अंदर अपील का दाखिला आवश्यक है।
4. अपील व्यक्तिगत रूप से अपर आयुक्त सीमाशुल्क (आयात), प्रथम तल, नवीन सीमाशुल्क भवन, बेलार्ड इस्टेट, मुंबई- 400 001 या उनकी ओर से अधिकृत किसी अधिकारी के समक्ष रखी जाए।

1. An application dated NIL filed by Shri Badrinath Iyengar, 704, Sundaram Vasant CHS, Mahavir Nagar, Kandivali (West), Mumbai - 400 067. (Hereinafter referred to as Applicant) under Right to Information Act, 2005, received in this department on 08.01.2019, from CPIO/Jt. Commissioner of Customs, RTI (Genl.), Mumbai Zone - I, vide F.No. RTICG/Gen-274/18-19 dated 08.01.2019.

2. Following information was sought by the Applicant under RTI Act, 2005

I have filed an RTI request with the below details but has not received any response for 2 months. My package has been held up at customs but I am being asked redundant forms to delay the process since the last 6 months. Registration Number CCEM2 R2017 50034 Date of Filing: 08 July 2017 Request filed with : Chief Commissioner, Central Excise, Mumbai -II Zone. Kindly assist me in getting justice to my request. My Memo number with customs is M-644-17.

3. RTI application is provided after due examination of the reply received from the concerned section, the reply of the RTI application is as follows :-



The complaint filed does not mention the tracking number of the consignment. The memo number M 644/17 mentioned has been cleared on 17.01.2017 and as per the records maintained in this office, Memo No. M 644/17 does not pertain to import by Shri Badrinath Iyengar.

However, on further verification, it is revealed that Shri Badrinath Iyengar had filed CP GRAM on the same issue wherein the item reference No is M 6445/17. It appears that information sought under the present RTI pertains to this article namely import of gold coin valued at Rs. 1,15,479/- . In this respect as was informed to Shri Iyengar in reply to the CP GRAM, the subject case was adjudicated by AC/PAS on 25.09.2017 vide Order-in-Original CAO No. 726/2017-18 vide F.No. S/22-61/2017 PAS. Shri B Iyengar was directed to pay fine and penalty amounting to Rs. 33,600/- (Fine Rs.23,600/- and Rs.10,000/- penalty). Shri B. Iyengar has paid the said amount of fine and penalty vide Challan No.325/17.10.2017. It has also been confirmed by the postal authorities that the goods were despatched to Shri B Iyengar on 28.10.2017.

As Shri Iyengar has already paid the duty, fine and penalty and the goods have been duly received by Shri B Iyengar, no action is pending from Postal Appraising Section and hence in the circumstances, the matter is closed.

4. An appeal against this order may be made under section 19(1) of the RTI Act 2005 to the First Appellate Authority (FAA):-




