"Shri Jagdeep S. Rana was not posted in Mumbai, Zone I in April, 2015 and the LPC of the officer was not issued by this Custom House."

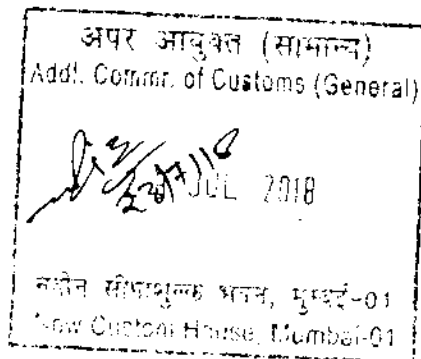


