PUBLIC NOTICE No. 40/2018

Sub: Implementation of paperless processing under SWIFT – Mandatory uploading of supporting documents w.e.f. 15.03.2018 – regarding.

It is brought to the notice of the trade, public and all stake holders that with the objective of reducing physical interface between Customs, other regulatory agencies and the trade, and to further enhance the speed of clearance of import cargo, it has been decided to introduce a facility to upload digitally signed supporting documents on a pilot basis at New Custom House, Mumbai.

2. Attention of the trade is invited to the procedure regarding implementation of paperless processing under SWIFT highlighted in CBEC Circular No. 40/2017-Customs dated 13th October, 2017.

1. In view of the same, it is suggested that Custom Brokers and self-filers are encouraged to use e-SANCHIT on a regular basis and it will be obligatory to upload documents with effect from March 15, 2018 to enhance the speed of import clearance.

Furthermore, separate counters will be earmarked for clearances involving mandatory verification documents in original (for example, Certificates of Origin), so that trade can visit only those counters submit the relevant hardcopies. Even such documents must be uploaded on e-SANCHIT before clearance.

To facilitate smooth functioning of this facility of uploading the supporting documents, the feedback, queries/difficulties, in implementation of this Public Notice (issued in reference to CBEC Circular No. 40/2017-Customs dated 13/10/2017), if any, shall be brought to the notice of the undersigned or may be addressed to the Deputy Commissioner of Customs (EDI), NCH, Mumbai (Deputy/Assistant Commissioner in charge of Appraising Main(Import-II), NCH, Mumbai.
