Sub: Oral Examination under Regulation 6 of CBLR, 2013-reg.

Kind attention is invited for the Oral Examination under **Reg. 6 of CBLR, 2013** which is scheduled to be held on **10th, 11th, 12th & 13th July, 2018** for all the candidates who are declared as **“Pass”** in the written examination held on **19.01.2018** as well as for those candidates who were declared **‘Pass’** in the Written examination held on **20.01.2017** but **‘Failed’** in the related Oral Examination.

The provisions of **Reg. 6(5) of CBLR, 2013** are as follows:

“An applicant, who fails to clear the oral examination within two years from date of declaration of result of the related written examination, shall be treated as having failed in the examination”.

Accordingly, candidates who were declared **‘Pass’** in the written examination held on **28.01.2016** or before but **‘Failed’** in the subsequent Oral Examinations are not eligible for the scheduled Oral Examination.
