MEMORANDUM OF CANCELLATION

The following 34 candidates had been sponsored by Staff Selection Commission for the post of Tax Assistant through SSC CGLE-2024. Letters were issued to 11 candidates (Sr. No. 1 to 11) for completion of pre-employment formalities i.e. Medical Examination and Document Verification, with a direction to report on or before the specified date. These candidates did not report in the office despite the offered sufficient opportunities and time.

08 Candidates at (Sr. No. 12 to Sr. No. 19) were issued provisional offer of Appointment and they completed the pre-employment formalities i.e. Medical Examination and Document Verification. The candidates did not join the department after this and did not provide any Extension request.

15 Candidates at (Sr. No. 20 to 34) were issued provisional offer of Appointment and they completed their pre-employment formalities i.e. Medical Examination and Document Verification, and further on their request they were granted extension for joining time, the candidates did not join within the stipulated time. As per DoPT's guidelines, an Offer of Appointment automatically expires after lapse of a period of six months from the date of issuance of original Offer of Appointment and in all these cases a period of six months has been expired

In view of the above, with approval of the Competent Authority, the candidature of following 34 candidates is henceforth cancelled and no representation in this regard will be entertained by this office in future.
