FINAL RESULT NOTICE

Subject: - Declaration of Final Result of Computer Base Examination (CBE) for Recruitment to the Post of Canteen Attendant, 2025.

The Computer Based Examination (CBE) for recruitment to the post of **Canteen Attendant, 2025** was conducted by the Office of the Commissioner of Customs, Mumbai Customs Zone-I on **24.05.2026** at designated examination centers.

1. A total of 1,396 candidates appeared in the Computer Based Examination. Thereafter, the candidates shortlisted for the next stage of the recruitment process were called for Document Verification (DV). Total 47 candidates were provisionally selected for DV and 38 candidates appeared for the Document Verification held on 18.08.2026 at New Custom House.
2. The result of the Computer Based Examination has been prepared on the basis of the Final Answer Key in accordance with the provisions of the Recruitment Notice and the applicable Recruitment Rules.
3. The candidature and documents of the candidates shortlisted for Document Verification have been examined/verified as per the applicable provisions. Based on the performance in the Computer Based Examination, fulfillment of the prescribed eligibility conditions and verification of documents, the **Final Result** for recruitment to the post of Canteen Attendant, 2025 is hereby declared.
4. The category-wise break-up of vacancies is as under:

*The 01 vacancy reserved for ESM could not be filled due to non-availability of an eligible ESM candidate and, accordingly, the said vacancy shall be **carried forward for being filled in accordance with the applicable Government of India/DoPT instructions on reservation for Ex-Servicemen**, subject to the provisions of the relevant Recruitment Rules and subsequent recruitment action.

5. Based on the performance of candidates in the Computer Based Examination and after applying the applicable reservation provisions, the following category-wise cut-off marks have been fixed for Final Selection.

* In addition, **00 SC, 00 ST, 01 OBC and 02 EWS candidates** have qualified at the UR cut-off on their own merit and have been shown in their respective social category at this stage. Such candidates qualifying on their own merit shall not be counted against the reserved vacancies, in accordance with the applicable reservation provisions.

Note: The PwBD (VH) candidate has been selected against the **OBC category** and the ESM candidate has been selected against the **UR category**, as per the applicable provisions relating to horizontal reservation.

7. The candidature of all the above **provisionally selected candidates is subject to verification of documents/certificates, eligibility, category/reservation claims, antecedents, medical fitness and fulfillment of all other conditions** prescribed in the Recruitment Notice, applicable Recruitment Rules and Government instructions.

8. The candidates claiming reservation benefits shall be required to fulfill all the conditions prescribed for availing such benefits. The genuineness and validity of the relevant certificates, wherever applicable, shall be subject to verification from the competent issuing authority.

9. The provisional selection of a candidate shall be liable to cancellation at any stage if the candidate is found ineligible, if any information furnished in the application form is found to be incorrect/false, if any document/certificate is found to be invalid or not genuine, or if the candidate fails to fulfill any of the prescribed conditions of recruitment.

10. Mere inclusion of the name/roll number of a candidate in this Final Result Notice does not confer any indefeasible right to appointment. Appointment shall be subject to fulfillment of all eligibility conditions, satisfactory verification of documents and antecedents, medical fitness and completion of all other prescribed formalities by the competent authority

11. Resolution of Tie Cases

In case where two or more candidates have secured equal aggregate marks in the Computer Based Examination, the inter-se merit has been determined by applying the following tie-breaking criteria in the order given below:

- (i) Candidate securing higher marks in the Numerical Aptitude Section.
- (ii) Candidate older in age;
- (iii) Alphabetical order of the names of the candidates.

12. The schedule for the **Medical Fitness Test** shall be uploaded separately on the official

website of Mumbai Customs Zone-I. The provisionally selected candidates are advised to regularly visit the official website for further updates and instructions.

13. The final appointment of the selected candidates shall be subject to the candidate being found **medically fit**, verification of antecedents and satisfactory completion of all other requisite formalities.

14. The candidature/selection of all candidates shall remain subject to the outcome of any litigation or court case, if any, pending before any Court of Law/Tribunal having jurisdiction in the matter.

15. While every care has been taken in preparing the result, the **Office of the Commissioner of Customs, Mumbai Customs Zone-I reserves the right to rectify any inadvertent error, omission or typographical mistake detected at any stage of the recruitment process.**
