4. Candidates may note that the sequence of the questions and the answer options displayed in the Response Sheet(s) may differ from the order in which they appeared during the actual examination. This is due to the system-generated display format. However, the responses submitted by each candidate during the examination have been accurately reflected.
5. Candidates are advised to carefully verify their Response Sheet(s) and Tentative Answer Key(s) for their own reference.
6. The downloaded **Question Paper, Tentative Answer Key(s), and Response Sheet(s)** are provided strictly for the personal use and self-analysis of the candidate only. Candidates shall not publish, reproduce, circulate, share, or otherwise misuse the contents in any manner.
