- iii. Cases of death of Government servants till 31.03.2023 in which family pension has not been sanctioned till date.
- iv. Cases of death of Government Servants in the performance of duty till 31.03.2023 in which only provisional/ordinary family pension has been sanctioned and family pension under CCS(EOP) Rules has been claimed.
- v. Cases wherein Death Certificate of the pensioner has been submitted to Pension Disbursing Bank and Family Pension not started within one month of receipt by the bank if the name of the Family Pensioner is given in the PPO.
- 2. Following types of grievances/cases shall not be entertained in the Pension Adalat
- (i) Cases involving purely legal points e.g. Succession etc.
- (ii) Grievances involving Policy matters.
- (iii) Issues like appointment on compassionate ground.
- (iv) Rentation of quarters after retirement and Recovery of Penal/damage rent relating thereto.
- (v) Any other issues not found lying within the domain of Pension Adalat in terms of Office Memorandum dated 09.02.2015 f. No. C30013/77/2014-Ad IV. A0 read with Office Memorandum dated 25.03.2011 of DOPPW (F. No. 44013/2/2010-Coord)
- 3. Circular and format of application may also be downloaded from the Pension Adalat Page on official website of Mumbai Customs.

4. Any applications/ grievances received after 11th September, 2023 shall not be considered for redressal in the proposed Pension Adalat on 20th September, 2023.
