ESTABLISHMENT OFFICE ORDER NO.45/2023

Consequent upon acquittal of Shri Santosh K Talpade, Adhoc Superintendent in Criminal Proceedings filed by DRI in Criminal Complaint No. 43/S/2003 and on completion of currency period in O-I-O dated 27.05.2011, the sealed cover kept in the review DPC dated 07.09.2018 that continued the sealed covers made in review DPC dated 20.01.2015(for Vacancy Years 2003-04 to 2014-15) was opened.

2. Accordingly, Shri Santosh K Talpade is hereby promoted to the grade of Appraiser in Level 8 in 7th CPC pay matrix (pre-revised Pay Band Rs. 9300-34800 with grade pay of Rs. 4800/- of 6th CPC) on regular basis in ST Category against the vacancy year 2012-13, notionally w.e.f. 20.07.2012 from the feeder cadre of Inspector (Preventive Officer).

3. Shri Santosh K Talpade shall be placed at Sr. No. 135A below Ajay Kumar Srivastava (Sr. No. 135) and above Shri Ritesh Jaiswal (Sr. No. 136) in the final seniority list of Appraisers of Mumbai Customs issued vide Circular No. 49/2018 dated 13.12.2018 for the period 01.04.2003 to 31.12.2013.

4. Shri Santosh K Talpade may exercise the option for fixation of pay in terms of FR-22(1)(a)(i) as per DOPT OM 27.07.2017 issued vide No. 13/02/2017-Estt(Pay-I) in the higher grade afresh within one month of the date of issuance of this order. Such option once exercised shall be treated as final.

5. The officer shall not be eligible for any arrears of salary and allowances on account of notional promotion.

6. The officer may assume the charge of Appraiser before 22.02.2023 at their present place of posting failing which it will be construed that he is not interested in accepting the promotion. Failure to assume the charge will be deemed as refusal to accept the promotion offered to him and action in terms of DOPT OM no. 22011/5/86-Estt.(D) dated 10.04.1989 (as amended) shall be initiated.

7. The subject promotions being effected under this order are subject to the final
