On the basis of the recommendation of the Departmental Promotion Committee (DPC) meeting held on 28.02.2023 for regular promotion to the grade of Superintendent of Customs (P) for the year 2023, the following Inspector (Preventive Officers) of Mumbai Customs is hereby promoted to the grade of Superintendent of Customs(P) in Level 8 in 7th CPC Pay Matrix (prerevised) Pay Band Rs.9,300-34,800/- with Grade Pay of Rs.4,800/-) with immediate effect on regular basis from the dates shown against their names. However, they will be entitled for pay and allowances in the next grade of promotion from the date of assumption of charge in the new grade;

- The officers promoted on regular basis, must assume charge as Superintendent of 2. Customs (P) at his present zone / place of posting with immediate effect and latest by 05.06.2023 failing which it will be construed that he/she is not interested in taking up the promotion. Failure to assume charge will be deemed as refusal to accept the promotion offered to him and action in terms of DOP&T O.M. No. 22011/5/86-Estt. (D) dated 10.04.1989 (as amended) read with DP&AR O.M. No. 22034/3/81-Estt (D) dated 01.10.1981 shall be initiated.
- The promoted officer would continue to work on in-situ basis till the issuance of his posting 3. order.
- The promotion would take effect only after assumption of charge at the concerned zone / place of posting. A copy of the assumption of charge should be endorsed to the Personnel and Estt. Section (Preventive), New Custom House, Mumbai, Zone-I and Pay and Account Section of the concerned Zone.
- This order is subject to the final outcome of the SLP No.30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors) pending before the Hon'ble Supreme Court of India, and / or any relevant pending case in Hon'ble Tribunal / Hon'ble High Courts / Hon'ble Supreme Court of India and / or any direction of the Ministry pursuant to any judicial order.
- The pay and other allowances of the promoted officers in the grade of Superintendent (P) will be granted only from the date they assume charge. No officers would be entitled for any arrears of pay on this account.

The Controlling Officers shall also ensure that if the officer whose name mentioned in the 7. list of Para 1 above, is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Superintendent(P) and this fact should be reported to P&E(Prev.), New Custom House, Mumbai Zone – I, immediately.
