ESTT. OFFICE ORDER NO. 336 / 2024

2. The promoted Officers must assume charge not before 01.01.2025 and latest by 15.01.2025, failing which it will be construed that they are not interested in accepting the promotion. Failure to assume charge shall be treated as refusal to accept the promotion offered to the officer and action in terms of DOPT OM No. 22011/5/86-Estt. (D) dated 10.04.1989 shall be initiated.

3. The controlling officer shall ensure that if any of the officers whose name figure in this order is under suspension or facing any charge-sheet or prosecution, he/she should not be allowed to assume charge of the post and this should immediately be reported to the P&E Section, NCH, Mumbai Zone-I. Further, if any of the officers is undergoing any penalty, he/she should be allowed to assume the charge of the post only after the expiry of the currency of the penalty period and this should be reported to P&E section, NCH, Mumbai-I.



4. The promotion shall take effect only after assumption of charge at the concerned Zone/place of posting. A copy of the assumption of charge should be endorsed to the Personnel & Estt. Section, New Custom House, Mumbai-1 and respective Accounts Pay Bill Section of the Zones.

5. The pay and allowances of the newly promoted officers will be granted only from the date of assumption of charge. Promoted officers are entitled to exercise the option for fixation of pay on promotion in terms of F.R.-22(1)(a)(i) as per DOPT OM No. 13/02/2017-Estt. (Pay-I) dt 27.07.2017 within one month from the effective date of this order.

6. These promotions shall be subject to the outcome of any relevant pending case in any Tribunal/ High Court / Supreme Court of India and/or any review measure undertaken by this department in pursuance of any decision of any Tribunal/Court and/or any direction of the Ministry pursuant to any judicial order.
