### DETENTION NOTICE

Under Section 142(1)(a)(b) of the Customs Act, 1962

Sub.: Recovery of demand of Differential Duty of Rs.68,360/- in respect of Bill of Entry No.5705812 dt. 16.11.2019 and Rs.1,79,115/- in respect of Bill of Entry No.5264935 dated 12.10.2019 (Total Rs.2,47,475/-) alongwith applicable interest vide Order-in-Original No.04/2022-23 dated 11.05.2022 passed by Deputy Commissioner of Customs, ICD Mulund, Mumbai - reg.

M/s. Mamta Fabrics(IEC: BBLPG9093E), Flat No.74, BLDG No.8/A, S S Nagar, Flank Road, Sion Koliwada, Mumbai - 400037 have failed to pay an amount of Differential Duty Recovery of Rs.2,47,475/- along with applicable interest confirmed vide Order in Original No.04/2022-23 dated 11.05.2022.

Now, therefore, in exercise of the power conferred by clause (a) of Sub-Section (1) of Section 142 of the Customs Act, 1962, I Asstt. Commissioner of Customs, ICD Mulund, Mumbai Zone-I require and request that the aforesaid amount along with interest, should be recovered from any money payable to M/s. Mamta Fabrics, Mumbai by all those officers of the Customs and/or officers of Central Excise (who have also been designated as officers of Customs) all over the Country. I, also further require and request in terms of clause (b) of subsection (1) of Section 142 of Customs Act. 1962, that the amount mentioned above should also be recovered by detaining and selling any goods belonging to the aforesaid party/person M/s. Mamta Fabrics(IEC: BBLPG9093E), Flat No.74, BLDG No.8/A, S S Nagar, Flank Road, Sion Koliwada, Mumbai - 400037 by the officers of Customs & Officers of Central Excise (who have been designated as officers of Customs) all over India.

An Intimation regarding recovery may be sent to the undersigned as soon as the amount is realized. The amount so recovered may be sent to the undersigned by Demand Draft drawn in favour of the "RBI A/c Pr. Commissioner of Customs, (General), Mumbai Zone-I".
