**MINUTES OF CUSTOMS CLEARANCE FACILITATION COMMITTEE
(CCFC) MEETING OF MUMBAI CUSTOMS, ZONE-I HELD ON
25.05.2023 AT NEW CUSTOMS HOUSE, MUMBAI**

The 2nd meeting of the Customs Clearance Facilitation Committee (CCFC) for the Financial Year 2023-24 for Mumbai Customs Zone-I was held on 25.05.2023 (Thursday) at 04:30 PM in the Conference Hall, 2nd Floor, New Customs House, Mumbai under the Chairmanship of Shri Pramod Kumar Agrawal, Principal Chief Commissioner of Customs, Mumbai Zone-I.

3. At the outset, the Chairman extended his greetings and welcomed all the members to the CCFC meeting. The Chairman informed that no agenda point has been received from trade partners and from other PGAs for the meeting. He stated trade partners and other PGAs to raise any point/issue which they wanted to discuss here.

4. The Chairman stated that during the last CCFC meeting held on 28.04.2023, BCBA agreed to host an Open House Meeting with all three Mumbai Customs Zones, PGAs and trade partners. However, he informed that no intimation in this regard has been received from BCBA. Shri Dushyant Mulani, President, BCBA stated that they will send email shortly to all three Mumbai Customs Zones and they are planning to host the meeting in mid of June month.

5. The Chairman, informed the trade partners about performance of the Zone in first two months of current F.Y. 2023-24. He informed that revenue collection for first two months was good. The port clearance is now available 24*7. He informed that considering the requests of stakeholders, G-category examination for the year 2023 has been postponed to 11.06.2023 and last date for submission of applications has been extended to 25.05.2023. He informed that CBLMS portal is functioning smoothly and is being monitored regularly. All functionalities of CBLMS are now available online. The Chairman informed about Amnesty Scheme for one-time settlement of default in export obligation by Advance and EPCG authorization holders, launched by Ministry of Commerce and Industries. He requested trade partners to avail the benefits of this scheme as this scheme is available till 30.06.2023 only. He stated that Electronic Cash Ledger (ECL) facility is functioning properly. In last two weeks, only one manual challan was generated and only 6 manual challans were left for integration as far as this Zone is concerned.

6. With the permission of Chair, Shri Dushyant Mulani, President, BCBA stated that there is an issue of integration of PAN based payments of manual challans due to difference in PAN card of a company and its director(s) or person depositing duty. The Chairman asked him to submit a detailed representation in this regard so that the DG Systems/ICES may be requested to issue an advisory on the issue.

Shri Dushyant Mulani, President, BCBA raised another issue that if a challan is returned back due to some technical glitches or systems issue then local System Manager should be empowered to waive interest in such cases. The Chairman asked Shri Dushyant Mulani to submit a letter on the matter and stated that the same shall be examined for proper action by department.

Shri Dushyant Mulani, President, BCBA informed that after the operationalization of System 2.0, importers/CBs are not receiving Examination Order on their registered mail ID from ICEGATE. This is causing hardship to them. He mentioned that earlier in System 1.5 regime, importers/CBs used to receive examination order of the goods through email by ICEGATE once registration of bill of entry and duty payment was done. The Chairman directed Dy. Commissioner/Docks to submit a detailed report in this regard and also requested BCBA to

make representation on their demand in this regard.
