**DETENTION NOTICE**  
**Under section 142 (1)(a)(b) of the Customs Act, 1962**

**Sub: Recovery of Government dues of ₹ 30,23,726/- along with applicable interest, Redemption Fine of ₹ 3,00,000/- & Penalty of ₹ 6,00,000/- from M/s CONCEPT PHARMACEUTICALS LTD. (formerly CONCEPT INTERNATIONAL) (IEC: 0389012033).**

M/s CONCEPT PHARMACEUTICALS LTD. (formerly CONCEPT INTERNATIONAL) (IEC: 0389012033) having registered address at 167, CST Road, Kalina, Santacruz (E), Mumbai-400098 and 801-B, Hubtown Solaris, N. S. Phadke Marg, Near Andheri Flyover, Andheri (East), Mumbai – 400 069 has failed to pay the Government dues pending for recovery which has been confirmed by the Adjudication Authority i.e. Joint Commissioner of Customs Export, New Custom House, Mumbai Zone-I, vide Order-in-Original No. 117/AKN/JC/DEEC(Exp)/2022-23 dated 22.12.2022.

Now therefore, in exercise of powers conferred by Clause (a) of the sub-Section (1) of Section 142 of the Customs Act, 1962, I require and request that the amount of ₹ 39,23,726/- (Duty of ₹ 30,23,726/- along with applicable interest + Redemption Fine of ₹ 3,00,000/- & Penalty of ₹ 6,00,000/-) should be recovered from any money payable to the above said firm by all officers of Customs and/or officers of Central Excise (who are also designated as Officers of Customs) all over the country. I also require and request in terms of clause (b) of the sub-Section (1) of the Section 142 of the Customs Act, 1962 that the said amount also be recovered by detaining and selling any goods belonging to the aforesaid firm, by the officers of Customs and/or officers of Central Excise (who are also designated as officers of Customs) all over India.

The intimation regarding the recovery may be sent to the undersigned as soon as the amount is realized. The amount so recovered may be sent to the undersigned by Demand Draft in favor of “RBI A/c Commissioner of Customs (Export), Mumbai Customs Zone-I”.
