2. The officers mentioned above shall be relieved latest by 02.07.2026 without fail and must join their new place of posting latest by 03.07.2026. No representations whatsoever shall be entertained before they join their new place of posting. Any representation (Post AGT) shall be forwarded through the proper channel with the approval of the Chief Commissioner of the specific zone, as defined in the transfer posting policy governed by S.O 09/2017.

3. All the Controlling officers must ensure that all the important/urgent/unfinished works/matters are completed/ handled/ adequately concluded/attended to in the intervening period so as to ensure timely relieving of the above/mentioned officers. Non relieving of any officer by the last date for exceptional administrative requirement shall be approved by the jurisdictional Commissioner and thereafter forwarded to the office of Pr. Commissioner (General), Mumbai Zone-I, with the approval of the Chief Commissioner of the concerned zone, for action at this end.

4. All the respective zones may issue their Intra-Zonal posting orders by 25.06.2026.

5. ASO & PSO (Appraising) sections of respective zones shall forward the compliance report regarding relieving and joining of officers latest by 06.07.2026.

6. All Examiners transferred by this order to/from Zone-I/Zone-II/Zone-III shall report to P & E Section, NCH, Mumbai, before joining their next place of posting.

7. All representations/requests received so far from Examiners regarding posting in AGT-2026 hereby stand disposed of.

8. It is the responsibility of the concerned controlling authorities to ensure non-sensitive charges/posting to the officers not clear from vigilance angle.

9. Officers already posted to sensitive charges/sections and transferred to a different zone in this order should be accommodated in non-sensitive postings for the first cycle of posting, as far as possible, as per policy.
