

CIRCULAR No. 17/2023

All the concerned are hereby informed that the transfer and posting policy in the grade of Appraisers and Examiners is governed by Standing Order No.09/2017 dated 25.04.2017 as amended vide Standing Order No. 05/2022 dated 06.05.2022. The Annual General Transfers (AGT – 2023) in the grade of Appraisers & Examiners is under consideration.

- 2. Therefore, to consider and accommodate requests from officers regarding posting to a specific zone on the basis of spouse/dependent/medical grounds etc., representations are being invited prior to this exercise.
- 3. Representations are also sought from the Appraisers posted to Outstation regarding reduction in the tenure of Outstation in terms of Standing Order No. 05/2022 dated 06.05.2022 on the basis of appropriate grounds.
- 4. All the representations should be as per the format attached herewith and should be accompanied with documentary proof such as medical certificate etc. so that the cases may be considered on merit. The representations should be submitted through **proper channel** latest by 28.02.2023.
- 5. A duly signed, advance copy of the representation, if any may be submitted to the Deputy Commissioner of Customs, P&E Section, Mumbai Customs Zone-I at <u>p.estt-mum-cus-zone1@gov.in</u>. Representations submitted after the due date will not be considered.
- 6. Submission of a representation does not guarantee their acceptance as all representations will be decided on merit. It is also clearly informed that the posting of a Government servant is not a matter of right/choice but an administrative arrangement to run the department smoothly.
