

## ESTT. OFFICE ORDER NO.: 245/2023.

On the basis of the recommendation of the supplementary Departmental Promotion Committee (DPC) meeting held on 27.02.2023 & 28.02.2023 for regular promotion to the grade of Appraiser for the vacancy year 2023, the following Inspector (Examiner) of Mumbai Customs is hereby promoted to the grade of Appraiser in **Level 8 in 7<sup>th</sup> CPC Pay Matrix** (pre-revised) Pay Band Rs.9,300-34,800/- with Grade Pay of Rs.4,800/- with on regular basis w.e.f the date mentioned below-

- 2. The officer promoted on regular basis, must assume charge as Appraiser at his present zone / place of posting with immediate effect and latest by **08.08.2023** failing which it will be construed that he/she is not interested in taking up the promotion. Failure to assume charge will be deemed as refusal to accept the promotion offered to him and action in terms of DOP&T O.M. No. 22011/5/86-Estt. (D) dated 10.04.1989 (as amended) read with DP&AR O.M. No. 22034/3/81-Estt (D) dated 01.10.1981 shall be initiated.
- 3. The promoted officer would continue to work on in-situ basis till the issuance of his posting order.
- 4. The promotion would take effect only after assumption of charge at the concerned zone / place of posting. A copy of the assumption of charge should be endorsed to the Personnel and Estt. Section (Appraising), New Custom House, Mumbai, Zone-I and Pay and Account Section of the concerned Zone.
- 5. This order is subject to the final outcome of the SLP No.30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors) pending before the Hon'ble Supreme Court of India, and / or any relevant pending case in Hon'ble Tribunal / Hon'ble High Courts / Hon'ble Supreme Court of India and / or any direction of the Ministry pursuant to any judicial order.
- 6. The pay and allowances of the newly promoted officers in the grade of Appraiser will be granted only from the date of assumption of charge. Promoted officers are entitled to exercise the option for fixation of pay on promotion in

terms of FR-22(l)(a)(i) as per DoPT OM dated 27.07.2017 issued vide No.13/02/2017-Estt(Pay-I). They are hereby directed to exercise their option within one month from the date of this order. No officers would be entitled for any arrears of pay on this account.

7. The controlling officers to whom the officer will submit assumption of charge shall also ensure that if the said officer is under suspension or charge-sheet has been issued or prosecution has been launched, then officer should not be allowed to assume charge of the post of Appraiser and this fact should be reported to Additional Commissioner of Customs, P&E, New Custom House immediately.
