**ESTABLISHMENT OFFICE ORDER NO. 83/2026**

Based on the recommendations of the Review DPC meeting for promotion to the grade of Inspector (Examiner) under One Time Relaxation granted vide CBIC's letter F. No. A-12018/02/2017-Ad.IIIB dated 22.05.2026, the following Executive Assistants are hereby promoted to the grade of Inspector (Examiner) [Group 'B' Non-Gazetted] on regular basis with notional effect from 01.01.2026 in Level-7 of 7<sup>th</sup> CPC [6<sup>th</sup> CPC Pay Band-2 (Rs 9300-34,800) & Grade Pay Rs. 4600/-] for the vacancy year 2026:

2. The aforementioned officers are required to assume charge on or before 15.06.2026 (A/N) at their present zone/place of posting failing which it will be construed that they are not interested in accepting the promotion. Failure to assume charge in the promoted grade of Inspector (Examiner) by 15.06.2026, will be deemed as refusal to accept the promotion offered to them. This in turn will attract initiation of action in terms of DOP&T OM No. 22011/5/86-Estt.(D) dated 10.04.1989 read with DPAR OM No. 22034/3/81-Estt.(D) dated 01.10.1981. Promotion of all such officers, who forgo promotion, shall be treated as cancelled and they will be debarred for regular promotion to the grade of Inspector (Examiner) for one year from the date of refusal of the promotion or till the next DPC, whichever is later.

3. The promotions would take effect only on assumption of charge at the present zone/place of posting. A copy of assumption of charge duly acknowledged by the present controlling office should be endorsed to the Assistant Commissioner of Customs, Personnel & Establishment Section, New Custom House, Mumbai Zone-I and respective Appraising / Accounts Pay Bill Sections latest by 17.06.2026. The assumption of charge must be sent by the officer through his official gov e-mail Id, to P&E Section's e-mail Id at cuscum1-appraising@gov.in.

4. The pay and allowances of the promoted officers in the grade of Inspector (Examiner) will be granted only from the date of assumption of charge as the promotion is purely on notional basis

w.e.f. 01.01.2026. Promoted officers would not be entitled for any arrears on account of notional promotion from an earlier date. However, the pay of officers, who have been given notional promotion, may be fixed from the said date of their promotion. Promoted officers are entitled to exercise the option for fixation of pay on promotion in terms of FR-22(1)(a)(i) as per DOPT OM dated 27.07.2017 issued vide No.13/02/2017-Estt(Pay-I). They are hereby directed to exercise their option within one month from the date of this order.


5. On assumption of charge, the afore mentioned Inspector (Examiner) will work on in-situ basis till the issuance of their posting orders in the grade of Inspector (Examiner). The seniority of the promoted officers will be fixed in due course as per the orders in force.

6. The subject promotion being affected under this order is subject to the final outcome of any case pending before any court of law, having any impact on the seniority and promotions in the grade of Appraiser/ Inspector (Examiner) and is also subject to any review measures taken by this Department regarding seniority and promotion in pursuance of any decision in any Court Case.

7. In view of DOPT instructions issued vide OM F. No. 36012/11/2016-Estt. (Res-I) {Pt-II} dated 15.06.2018, all such promotions are subject to further orders which may be passed by the Hon'ble Supreme Court of India in SLP No. 30621/2011 (Jarnail Singh & Ors vs Lachhmi Narain Gupta & Ors) or in similarly connected matters.

8. The controlling officers concerned shall ensure that if any of the promoted officers in this order is under suspension or facing any charge sheet or prosecution, he shall not be allowed to assume the charge of the post of Inspector (Examiner) and all such cases must be reported to Additional Commissioner of Customs, P&E, New Custom House, Mumbai immediately. Further, if any of these officers is undergoing any penalty, he/she shall be allowed to assume the charge of the post of Inspector (Examiner) only after the expiry of the currency of the penalty period. Such cases may also be reported to Additional Commissioner of Customs, P&E, New Custom House immediately.
