2. The following officer, who was transferred in previous AGTs but not joined in their respective place of posting, should be relieved immediately.



3. The officers mentioned above shall be relieved latest by 30.06.2023 without fail and must join their new place of posting latest by 01.07.2023. No representations whatsoever shall be entertained before they join their new place of posting.
4. All the Controlling officers must ensure that all the important/urgent/unfinished works/matters are completed/handled/ adequately concluded/attended to in the intervening period so as to ensure timely relieving of the above-mentioned officers. Non relieving of any officer by the last date for exceptional administrative requirement shall be approved by the jurisdictional Commissioner and thereafter forwarded to the office of Pr. Commissioner (General), Mumbai Zone-I, with the approval of the Chief Commissioner of the concerned zone, for action at this end.
5. All the respective zones may issue their Intra-Zonal posting orders by 15.06.2023.
6. Officers already posted to sensitive charges/sections and transferred to a different zone in this order should be accommodated in non-sensitive postings for the first cycle of posting, as far as possible, as per policy.
7. Officers at Sr. No. 30 to 37 in Table B are currently undergoing Induction Training of 14 weeks. These officers will be relieved for respective Zones, on successful completion of Induction Training, by P&E, Zone-I as per Boards' instructions.
8. ASO & PSO (Appraising) sections of respective zones shall forward the compliance report regarding relieving and joining of officers latest by 08.07.2023.
9. All representations/requests received so far from Examiners regarding posting in AGT- 2023 hereby stand disposed of.
10. It is the responsibility of the concerned controlling authorities to ensure non-sensitive charges/posting to the officers not clear from vigilance angle.
