Shri SOURIN SAHA (Roll No.- 7204722402, Rank-SL/III/01133), candidate belonging to SSC WR Region, was recommended for appointment as Inspector (Preventive Officer) on the basis of result of Combined Graduate Level Examination-2019 and allotted to Mumbai Customs Zone by Central Board of Indirect Taxes and Customs.

After completion of Pre Appointment formalities i.e. Medical Examination, Physical Standard Test and Document Verification, Offer of Appointment was issued to the candidate on 22.10.2022 with a direction to report on duty on or before 18.11.2022. Further, as requested an extension in joining till 18.02.2023 was granted by the competent authority. However, the candidate vide his mail dated 15.02.2023 has relinquished the opportunity and hadn't approached to join the duties as Inspector (Preventive Officer).

Thus, the offer of appointment has lapsed after completion of six months period from the date of issue of Original Offer of Appointment as per DoPT O.M. No. 35015/2/93-Estt.(D) dated 09.08.1995.

In view of the above, the candidature of Shri SOURIN SAHA, is henceforth cancelled and his dossier is being returned to the Staff Selection Commission and no representation in this regard will be entertained by this office in future.
